TERMS OF AGREEMENT

To book Rena as a performer, a \$75 non-refundable deposit is required at least one week before the event. Payment is accepted via PayPal, credit card or cash only to secure the booking. The remaining balance must be paid in full by cash, certified check or company check immediately following the performance.

At times, the performer will have more than one engagement on any given night, thus it is important that the show start at the scheduled time. If the performer is required to start more than 15 minutes late, an additional \$25 charge will apply per 15 minute interval thereafter.

Parking must be available for the performer. All parking fees (if any) are the responsibility of the client. If the performer must use the valet as an option, it must either be prepaid or a valid voucher provided.

The client is responsible for providing the performer with a clean and hazard-free dance space, working sound system and a private area where the performer can change and store belongings. If the dance space is outdoors, the client must ensure that the area is safe and that outdoor speakers are available and set up prior to the show.

The performer will provide all music for the show either on a pre-recorded CD or cued iPod which will be handed to the client upon arrival at the venue on the day of the event.

In traditional Arabic culture, it is part of a Belly Dance show to give and receive tips. Tipping is optional; however, guests may feel free to show their appreciation either in the traditional way, by “showering” the performer with money during her show, or by handing it to her during or after the performance.

The performer may not be touched or harassed; inappropriate or lewd remarks will not be tolerated under any circumstances. The performer reserves the right to leave the event at any time should she feel threatened and all fees will be due immediately.

48-hour cancellation notice is required or full fees due. Any fees incurred, such as a returned check fee on either the deposit or remaining balance will be charged to the client.

Audience members, clients and students of the hired entertainer waive the right to legal action for any injury(ies) sustained while participating in any service offered through this agreement. The performer is released from all liability for illness, injury, medical bills or any other expenses incurred through participation in the performance or its related activities.
